Running the Application

- Double-click on the app icon or "CurationExhibitions.exe" file to start the virtual exhibition.
- By running this application you agree to the EULA (license) below.

Controls: How to Explore the Virtual Gallery

There are 4 options for moving around:

- 1. Use the arrows on your keyboard.
 - o UP and DOWN to move forward and back. LEFT and RIGHT to turn.
- 2. Use the arrow buttons in the lower-right corner of the screen.
- 3. Double-click on the floor of the gallery to move to that spot.
- 4. Use the WASD character keys on your keyboard.

Looking Around & Interacting

- Click and hold with your MOUSE or TOUCH PAD and drag to look around.
- Move your cursor over an artwork and click to zoom in (click again to zoom out)

Other Controls

- Select the menu icon in the top-left corner to move between different galleries.
- Select the menu icon in the top-left corner to change settings. This may include control options such as mouse sensitivity and movement speed (in some application versions).
- Press the M key to minimize/maximize the application (to exit full-screen view).
- Press ESCAPE to close the application.

Troubleshooting

You may see a security pop-up when you run the application for the first time.

This depends on which anti-virus software you have on your PC.

- Some anti-virus software may ask you confirm that you want to run the application.
- Some anti-virus software may ask to "white-list" the application (to prevent future pop-ups).

It is safe to open the application.

This should only be necessary the first time you use the app.
